The Common Council of the City of New Haven, Indiana, met at the City Administration Building on the 7th day of July at the hour of 7:00 p.m. in a regular session in accordance with the rules of the Council.

The meeting was called to order by Steve McMichael who presided.

Mayor Steve McMichael asked everyone to stand and recite the Pledge of Allegiance.


Clerk Treasurer Natalie Strock numbered and read by title only G-20-10 An Ordinance Establishing a Municipal Motor Vehicle License Excise Surtax and the Municipal Wheel Tax.

Under new business Item G, Planning Director Rob Gutierrez discussed the update to New Haven Zoning Ordinance. Rob described the update as "certainty and clarity" of what was already there. Plan Commission already reviewed and approved it, but he wanted to share with the Council.


Under council comments, council members spoke of fireworks rules, masks required in City Hall starting July 8, 2020, comments from the inaugural 4th of July Parade and Picnic, and update from Board of Works on July 7, 2020. Pone Vongphachanh gave an update on the City Revolving Fund for small businesses effected by COVID-19 and how Brightpoint was assisting with this process.

Under public comments, a Meadowbrook association resident discussed speeding in his neighborhood which will be getting three 4 way stops that were approved that morning at Board of Works. Two other City residents had questions about the wheel tax ordinance that was voted on earlier in the evening.

Terry Werling made a motion to adjourn the meeting. Dave Cheviron seconded the motion and the meeting was adjourned.
